4. Experience conducting a range of psychotherapeutic and assessment techniques to develop, implement and evaluate treatment plans according to each individual client and their needs.
5. Competence in assessment - Able to independently select and administer a variety of assessment tools and integrate results into a well-written report.
6. Awareness, sensitivity and skills in working professionally with diverse individuals, groups and communities who represent various cultural and personal background and characteristics.
7. Highly developed interpersonal skills, including written and oral communication; independent and advanced report writing skills.
8. Experience working collaboratively with other rehabilitation professionals.
